### DIRECTORS REPORT 2007-08

To,  
The Members,

Your Directors have pleasure in presenting the Seventh Annual Report of IIT BOMBAY ALUMNI ASSOCIATION together with the Audited Statement of Accounts for the year ended 31<sup>st</sup> March 2008.

#### **IIT Bombay Golden Jubilee**

IIT Bombay Golden Jubilee celebrations were launched on September 5, 2007, graced by the presence of the former President, Dr A P J Abdul Kalam. Numerous events and activities such as seminars, conferences, and lectures by distinguished personalities are being organised on the campus. The Distinguished Lecture Series was kicked off on October 6, 2007 with Astronaut Sunita Williams addressing the audience about both technical and personal experiences of her extra terrestrial 'holiday', as she called it.

The Silver Jubilee Reunion of the Class of 82 was celebrated in a grand fashion on December 28, 2007. Golden Jubilee Alumni Day was celebrated on December 29, 2007. In the Alumni Day formal function IITB Director Prof. Misra presented Distinguished Service Awards to Ajit Ranade, Shridhar Shukla, Praween Narwankar and Raj Menon. Representatives of class of 1980 and 1981 gave legacy project implementation updates. A donation of Rs. 25 lakhs was announced by the representatives of Class of 1981 to S.I.N.E. as Entrepreneurship Alumni Fund. Silver Jubilee batch of Class of 1982 presented a donation cheque of Rs. 4 crores to Prof. Misra towards their legacy project 'Project Joining Bonus to Young Faculty'. IIT Bombay will use this fund to attract talented young scholars from around the globe to take up faculty positions at IIT Bombay. Your Alumni Association announced the launching of a Benevolent Fund for members of the IITB family.

Golden Jubilee Foundation Day was celebrated on March 10, 2008. On this occasion, Mr. Anand Mahindra, Vice Chairman & Managing Director, Mahindra & Mahindra Ltd., who was the Chief Guest, presented Distinguished Alumnus awards to Jairaj Phatak, Arun Firodia, Rajeev Joshi, Ravi Gupta and Suresh Sethi. During the Golden Jubilee year your Institute has launched various projects like Convention Centre, Students' Gymkhana Revamp, Lecture Hall complex, new Hostels, etc. Your Institute is looking forward to your continued involvement and active support from you.



## **Operations**

Launching of three new chapters at Nagpur, Baroda, and New Delhi during Golden Jubilee Outreach was the highlight of the last year. Besides these cities, IITBAA conducted Golden Jubilee Outreach programmes at Pune, Hyderabad, and Bangalore. In order to reach out to as many alumni as possible, we are encouraging our members located at different geographical locations to come together and form new city chapters. We are setting up the right practices that will help build IITBAA into an ever-growing Institution. Our chapters at Mumbai, Pune, and Bangalore have their executive committee members elected by popular vote. IITBAA has embarked on undertaking various activities on the campus and as well as through its chapters, benefiting fellow Alumni, and our Alma Mater.

From June 1, 2008, Shirish Waghulde took over as CEO of our organization. Shirish has been involved with alumni activities for a long time and with his help we hope to attain new heights. Shirish is succeeding Milind Gokhale, who now works with the Development Office of IIT Bombay.

We acknowledge with gratitude that in the last four years with Milind Gokhale as the first CEO, our organization has made considerable progress. Our membership has grown four fold. We could set up our full-fledged office 'Alumni Centre' and 'Souvenir Shop' on the campus. We have been providing complete support to Database building activity and Alumni Reunions on campus. We have established four new chapters and launched Affinity Gold Credit card with CitiBank, which comes 'free for life' to our members.

## **Chapters:**

Our chapters have been active, holding regular events throughout the year. A feather in our cap was 'Innovation 2008 - Ideas in Practice', the two-day event organised by our **Pune Chapter** on January 5 & 6, 2008, which was attended by more than 200 members. Shri Raghunath Mashelekar inaugurated the event at Persistence System's Dewang Mehta Auditorium, Pune. The focus of this trend setting annual event is to provide a platform for budding entrepreneurs. This event was aimed at promoting interaction between innovators from various key industry segments such as Manufacturing, Biotech/Chemical, IT, and Communication; and the venture capitalist, financial community, and technical experts. The Pune Chapter will be holding this event annually. We hope that it will become the best forum in India to showcase innovations in practice.

The Pune Chapter organized a Golden Jubilee Outreach event on June 23, 2007 at Dewang Mehta Auditorium. The distinguished invitees and speakers were Prof. Ashok Mishra (Director), Prof. Juzer Vasi (Deputy Director), Prof. Dipan Ghosh (Co-convenor GJ), Girish Sohoni, Exec Vice-President of BAIF, Pramod Chaudhari, Chairman, Praj Industries, and Naushad Forbes, MD, Forbes Marshall. A discussion on the topic 'Innovation at Grassroots' by an eminent panel of distinguished guests was the highlight of the event. On this occasion a DVD on 'Innovations 2007' was released. A traveling exhibition was also arranged by IRCC/PRO depicting R & D progress and achievements of IITB.

On September 8, 2007, the Pune Chapter organised an interactive workshop on the Right to Information (RTI) Act at the Dewang Mehta Auditorium. The objective of the workshop was to make the urban elite understand how we can invoke RTI to make a difference in our civic life and particularly help improve governance. This workshop was conducted by leading RTI activist and IITB alumnus, Shailesh Gandhi along with Mr. Vijay Kuvalekar, the State Information Commissioner for Pune region, who shared his thoughts citing case studies.

Our **Mumbai Chapter** continued its tradition of the last 11 years of arranging a wide variety of events for PAN-IIT alumni. On June 3, 2007, a visit to SBT Plant at Love Grove Pumping Station was organised, where a beautiful green area belies the fact that this is a sewage treatment facility. Prof. H.S. Shankar (Chem. Engg., IITB) who has designed and commissioned the 3 MLD sewage treatment plant, based on his patented Soil Biotechnology Process (SBT), for the Municipal Corporation of Greater Mumbai gave a presentation and guided tour of his project.

On July 28, 2007 the Chapter invited fellow alumni Jitendra Bhatia and Subodh Jawadekar, to talk about their work, inspirations, and experiences, at the Ruia College auditorium. Both speakers are Chemical Engineers from IIT Bombay who have not only excelled in their profession but have made a name for themselves in the literary world winning various awards.

The Chapter organised alumni from all IITs to run under the Run for IIT banner in the Mumbai Marathon held in January, 2008. On December 15, 2007, at the Ruia Auditorium, IITB alumnus Madhur Kotharay gave a very informative talk on technique, training regimen, diet, clothes, and shoes required for the marathon. Nearly a hundred alumni participated in the marathon, 70 of them ran the half marathon, 5 finished the full marathon, and the rest settled for the dream run. We hope to organise alumni to run in the various marathons all over the world and raise funds for the IITs through sponsors who will back the participants.

On February 17, 2008, the Chapter organized a harbor cruise from Gateway of India, which was a family-networking event. On April 12, 2008, the award-winning documentary “Inconvenient Truth” was screened at the American Center.

Our **Bangalore Chapter** has been supporting Village Knowledge Centre programme at Ittamadu village with renewed vigour. They have plans to replicate this successful activity at few more villages in the neighboring areas.

The Bangalore Chapter had organized Golden Jubilee Outreach programme on July 21, 2008. The event was held at Hotel Royal Orchid Centre and more than 125 alumni attended it. Prof. Misra, Prof. Phatak, Prof. Banerji, and Prof. Uday Desai interacted with the alumni. On August 15, 2008, the chapter organized an Inter Hostel Cricket match, a family networking event at NRA ground.

Our **Hyderabad Chapter** had organized a Golden Jubilee Outreach event at ISB auditorium on July 14, 2007. The programme included an audio-visual show “Down Memory Lane”. Prof. U. B. Desai talked about “Outline of IIT-B's Golden Jubilee Year Plans”. Our alumni Shailesh Gandhi, Prof. Ranganekar joined in the Panel Discussion on “Golden Jubilee of IIT B: What it Means to Alumni.”

The **Delhi Chapter** was formed at the Golden Jubilee Outreach programme on January 19, 2008, at the Lecture Hall, India International Centre Annexe. The distinguished guest and speakers were Dr. Anil Kakodkar (Chairman IITB), Prof. M.G.K. Menon, Prof. S (Director IIT Delhi), Prof. Misra (Director IITB), Prof. Dipan Ghosh (Co-Convener Golden Jubilee). The programme also included an Audio-Visual “NEWS @ IITB”.

On June 8, 2007, the **Nagpur Chapter** was formed at the Golden Jubilee Outreach programme, at Vishveshwariya National Institute of Technology, Nagpur. Prof. D.B. Phatak (Convener Golden Jubilee) addressed the alumni. The programme also included the audio-visual show ‘Trip Down Memory Lane - Life at IITB’ and a panel discussion on the topic ‘IITB Golden Jubilee – the road ahead’.

The **Baroda Chapter** was formed at the Golden Jubilee Outreach programme on August 11, 2007, at Subhaag – Jewel Brushes Corporate Office. Prof. D.B. Phatak (Convener Golden Jubilee) addressed the alumni. The programme also included screening of a film on IIT Bombay.

### **Membership**

The membership base of the Association has been steadily increasing and it is now nearing 4000.

### **Financials**

The operations during the past year show a surplus of income over expenditure of about Rs. 3.4 lakhs. The Association has a reserve of about Rs. 78.75 lakhs created out of the membership fees and surplus of the past. The financial statements are attached herewith.

### **Future Plans**

Your Association has launched the “IIT Bombay Alumni Association Benevolent Fund” to help IITB family members in their time of crisis. We would like to raise the corpus of this Benevolent Fund through your donations. We plans to expand our activities by setting up new Chapters in the un-represented areas and provide a platform for interaction to all our members by organizing various events for social and professional networking.

We will be actively promoting the ‘free for life’ IITBAA affinity Gold credit card that was launched with Citibank N.A. The card has zero joining fees and zero annual charges. It sports a photo of the IIT-B Main Building and the logo of our association giving it an emotional value for our alumni.

Your Association also hopes to support the implementation of the IIT vision by helping various Alumni funded projects on campus. Your support is essential in getting sponsored research projects from Industries. An Alumni Centre Building on the campus is now being planned as part of the Golden Jubilee celebration. We hope to see this dream realized by 2009 with the help of generous Alumni contributions.

The Association will also set new paradigms for judging its success and contribution to the Institute and to the Nation. We see a glorious future and are presently laying the foundations for this.

### **Directors**

During the year, the board of directors had regular meetings and discussed various aspects of making the IITB-AA a vibrant organization.

In the Annual General Meeting held on 26<sup>th</sup> August 2007, members elected Urjit Yagnik, Ajit Ranade, and Parag Rele as Directors for a 3-years term. The Board co-opted Shridhar Shukla from Pune, Sanjay Jain from Bangalore, and Amit Goradia from Baroda to increase participation from around the country.

In accordance with the provisions of section 255 of the Companies Act, 1956 four of your directors, Dipak Sheth, Gita Govindarajan, Kirat Patel, and Manoj Kunkalienkar retire by rotation. All four are eligible for re-election.

The Board acknowledges the contribution of retiring elected directors Dipak Sheth, Gita Govindarajan, Kirat Patel, and Manoj Kunkalienkar and retired co-opted members Ananthanarayana, Asim Banerji, and Santosh Sabnis whose untiring support and guidance to the Association was most invaluable. The Board would also like to put on record its gratitude to the retiring nominee director Deepak Sevta for his support.
